Dear Street Entertainers Applicant:

Your current Street Entertainers License will expire on _____.

To renew your Street Entertainers License, please complete the Street Entertainers License Application in its entirety. All street entertainer applicants shall “obtained a license to do so” in accordance with their application (**Baltimore City Code Article 15, Subtitle 13-8**). The Miscellaneous Taxes and Licensing staff shall review and process all Street Entertainers License applications.

Street Entertainer means any person who, either alone or as part of a group:

1. performs on the streets of this City; and
2. solicits, encourages, or accepts donations before, during, or after the performance.

(Baltimore City Code Article 15 Sub. 15-1(g-1)).

The Street Entertainers License Application fee (renewal or otherwise) is a one-time, non-refundable application fee of \$25, to cover the cost of investigating and processing the application. (**Baltimore City Code Article 15, Subtitle 15-12(b)**).

The Street Entertainers License Application (renewal or otherwise) must include: (1) the applicant’s name and address; (2) the applicant’s age^A; (3) the type of entertainment for which the license is sought; and (4) the location or area for which the license is sought (**Baltimore City Code Article 15, Subtitle 15-12(c)**). **Caveat (A): All applicants shall be 21 years of age at the time of applying for a Street Entertainers License Application per BRC management.**

If a licensee seeks to modify the terms of her or his license (e.g., location or type of entertainment), the renewal application must be accompanied by a one-time, non-refundable application fee of \$25 (**Baltimore City Code Article 15, Subtitle 15-13 (c2)**).

Entertainer identification badge shall be of laminated plastic or other durable substance and shall bear: (1) the name and address of the licensee; (2) the type of entertainment for which the license is issued; (3) the location or area for which the license is issued; (4) the days or times to which the license is limited; (5) the year for which the license is issued; and (6) an identifying number that corresponds with the number of the license (**Baltimore City Code Article 15, Subtitle 15-14b(2)**).

Each entertainer must prominently display the badge while entertaining. If a badge is lost, the Board shall issue a replacement badge on payment by the licensee of a \$10 fee (**Baltimore City Code Article 15, Subtitle 15-14b(3&4)**).

A street entertainer may not: (1) set any fee or require any donation for his or her performance; or (2) suggest any minimum or maximum donation (**Baltimore City Code Article 15, Subtitle 15-16**).

A Street Entertainer's licensed maybe suspended or revoked if the licensee violates any provision of **Article 15 Subtitle 15**; the rules and regulations adopted under this subtitle; or any other applicable law of the State or City. On a street entertainer's 3rd violation of any provision, the Street Entertainer's license must be revoked. If a license is revoked, the former licensee may not apply for a new license until 1-year from date of revocation (**Baltimore City Code Article 15, Subtitle 18**).

A penalty of 10% and interest at the rate of 1% per month or fraction thereof shall be due on all licenses not obtained or renewed if application is not postmarked by licensee's Anniversary Date_____.
